### St. John the Evangelist Financial Year-end Report: July 1, 2022 - June 30, 2023

#### Year-end Financial Report:

The Finance Council presents the SJE financial performance for the fiscal year 2022-2023. As is our practice, we maintain at least six months of operating expenses in cash reserves to protect against unexpected fluctuations in offertory collections. For this 12-month period, operating revenues were 6% greater than budget, expenses were 30% greater than budget, and net operating activity was 33% greater than the budget. Net assets (assets - liabilities) grew by 4.4%.

We had another active year here at the parish with numerous projects and maintenance items occurring. First and foremost, our Beloved Disciple Commons was completed in September 2022, and our campaign has collected just over 80% of our 3-year campaign goal of \$250,000. An additional section of the Cemetery Columbarium was installed, adding an additional 42 niches. Our driveways and parking areas had cracks filled and were then resealed and restriped. New floodlights were installed on the rectory to enhance campus lighting.

Upcoming projects in this new fiscal year include replacing the refrigerator and freezer in the Parish Hall, caulking the new church windows, and replacing the smoke detectors and spotlights in the church.

The Finance Committee is working on a facility plan and we will keep you updated on their progress throughout this coming year!

Your contributions to Facilities Upkeep go toward the upkeep of our new and old churches, as well as the rectory and grounds. Thank you for your conscious giving and your continued generosity to our parish as we continue to GROW and SERVE our communities of Waynesville, Canton, Bethel, Cruso, and Clyde.
